1. Quality Assurance & Control (QA/QC) Protocol

1.1 Data Intake and Reconciliation

Data Collection	All required client-provided documents (RFDS, SA, MA, Site Photos, Previous CDs) must be received and logged prior to project initiation.	
Document	A Senior Drafter or Project Manager reviews and reconciles data	
Reconciliation	across all documents (e.g., equipment lists vs. mount analysis) to	
	identify and resolve conflicts before any drafting begins.	
Template	Final drawings are executed using Client-Provided Proprietary	
Integration	Templates, Layering Standards, and Line Styles to ensure

1.2 Internal Review Hierarchy

Every Construction Drawing package follows a mandatory two-step review process:

Stage	Responsible Role	Check Focus
Drafting & Execution	Primary Drafter	Accuracy of data transfer, scale, and clarity, ensuring compliance with client-provided scope (including all mount reinforcement details from the MA/SA).
Final Quality Gate	Senior Drafter / Project Manager	Final QA/QC Sign-off . Confirms drawing fidelity against all engineering source data, jurisdictional requirements, and internal standards.

1.3 Revision and Risk Mitigation Policy

TDS offers the following guarantee to mitigate project risk associated with documentation errors:

Policy	Guarantee
Revision	ZERO-COST REDLINE POLICY: All revisions stemming from TDS drafting
Cost	errors or standard carrier/jurisdictional redlines are completed at no additional cost to the client.
Turnaround	Errors determined to be on the part of TDS are treated as a 'Top Priority'
Time	Emergency . We commit to aligning the revision delivery time to the client's requested timeline (e.g., 4-hour hot redlines) to prevent field crew stand-down time.
